13		by Gu-Vo District Council Resolution No. GV-23-075 and approved by Legislative
14		Council Resolution No. 23-371; and
15	WHEREAS,	by Gu-Vo District Council Resolution No. GV-24-055, the Gu-Vo District has
16		authorized and submitted for review and approval its FY 2024 Gu-Vo District Pia-
17	1	Oik Community Budget Amendment No. 1, which is incorporated by this
18		reference and which will adjust operational and/or personnel line items; and
19	WHEREAS,	the Budget and Finance Committee has reviewed the FY 2024 Gu-Vo District Pia-
20		Oik Community Budget Amendment No. 1 and recommends its approval.
21	NOW, THERI	EFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
22		FY 2024 Gu-Vo District Pia-Oik Community Budget Amendment No. 1 effective
23		October 1, 2023, which will not change the FY 2024 Gu-Vo District Pia-Oik
24		Community Budget amount of \$402,990.43.
