

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2024 Gu-Vo District Ali Chugk Community Budget Amendment No. 1)**

**RESOLUTION NO. ~~24-205~~**

1 **WHEREAS, pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham**  
2 **Nation,**

3 **No district council shall expend district funds except pursuant to budgets**  
4 **authorized under resolutions of the district council and approved by the**  
5 **Tohono O'odham Council. The management of these funds shall be only**  
6 **by a treasurer or other authorized officer of the district council who has**  
7 **furnished a surety bond satisfactory to the treasurer of the Tohono**  
8 **O'odham Nation, and all expenditures of these funds shall be by checks**  
9 **signed by such treasurer or other authorized officer and the chairman or**  
10 **vice chairman of the district council.**

12 **WHEREAS, the FY 2024 Gu-Vo District Budget in the amount of \$5,529,425.24 was authorized**  
13 **by Gu-Vo District Council Resolution No. GV-23-075 and approved by Legislative**  
14 **Council Resolution No. 23-371; and**

15 **WHEREAS, by Gu-Vo District Council Resolution No. GV-24-054, the Gu-Vo District has**  
16 **authorized and submitted for review and approval its FY 2024 Gu-Vo District Ali**  
17 **Chugk Community Budget Amendment No. 1, which is incorporated by this**  
18 **reference and which will adjust operational and/or personnel line items; and**

19 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2024 Gu-Vo District Ali**  
20 **Chugk Community Budget Amendment No. 1 and recommends its approval.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
22 **FY 2024 Gu-Vo District Ali Chugk Community Budget Amendment No. 1 effective**  
23 **October 1, 2023, which will not change the FY 2024 Gu-Vo District Ali Chugk**  
24 **Community Budget amount of \$559,209.94.**

25 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2024 Gu-Vo**  
26 **District Budget as amended shall be managed and expended in accordance with**  
27 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and the**  
28 **Nation's laws, provided that any amendments or modifications shall be**  
29 **authorized under District Council resolution and submitted for prior approval by**  
30 **the Tohono O'odham Legislative Council.**

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10<sup>TH</sup> day of JULY 2024 at a meeting at which a quorum was present with a vote of 3,027.10 FOR; -0- AGAINST; -0- NOT VOTING; and 236.2[04] ABSENT, pursuant to the powers vested in the Council by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
