3		all governmental departments, subject to the approval of the Tohono O'odham
4		Legislative Council (Constitution, Article VII, Section 2(e)); and
5	WHEREAS,	Nation's Chairman Verlon M. Jose has appointed Jennie F. Becenti as the
6		executive director of the Department of Health and Human Services, subject to
7		the approval of the Legislative Council; and
8	WHEREAS,	the Appointed Officers law, 1 T.O.C. Chapter 4, establishes the process for review
9		of appointments by the appropriate oversight committee and the Council and the
10		documents required, including copies of the current job description, the
11		appointee's current resume, contact information, and current written
12		background investigation report; and
13	WHEREAS,	pursuant to Article III, Section 6(B) of the Legislative Rules of the Tohono
14		O'odham Legislative Council, the chairperson's "appointee to the position of
15		treasurer or other officers or heads of governmental departments shall not be
16		added to any Legislative Council session agenda for approval unless the
17		appropriate legislative committee interviews the appointee after receiving a
18		resume and written background investigation report" containing detailed
19		employment, education, credit, litigation, and other information necessary to
20		determine the appointce's qualifications and fitness; and
21	WHEREAS,	the Health and Human Services Committee has received and reviewed the
22		detailed written background report and other documents required by the
23		Legislative Rules, IT.O.C. Chapter 4, interviewed the appointee, and recommends
24		that the Legislative Council approve the appointment.
25	NOW, THERI	EFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
26		appointment of Jennie F. Becenti as executive director of the Department of
27		Health and Human Services; provided that Jennie F. Becenti shall serve until
28		replaced at the request of the Nation's chairperson.
