8	WHEREAS,	the Enrollment Program has determined that a member was originally approved
9		for membership by Resolution No. 18-454 and was mistakenly approved a second
10		time for membership by Resolution No. 24-153; and
11	WHEREAS,	the Enrollment Committee recommends that Resolution No. 24-153 be amended
12		to delete the member identified in the attached Amending Enrollment Resolution
13		List for August 2024.
