

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Amendments to Monthly Age 18 Reports for March 2020 and
June 2024 to Correct Names and/or Dates of Birth)**

RESOLUTION NO. 24-225

1 **WHEREAS,** the Constitution of the Tohono O'odham Nation vests the Tohono O'odham
2 Legislative Council with the power "to manage any funds within the exclusive
3 control of the Tohono O'odham Nation . . . and to appropriate these funds for the
4 benefit of the nation and its members" provided that "[a]ll expenditures of these
5 funds shall be pursuant to appropriations or budgets" authorized by resolution
6 or ordinance (Constitution, Article VI, Section 1(d)(2)); and
7 **WHEREAS,** on June 28, 1997, the Nation's voters approved Initiative No. IN-01-97, the
8 "O'odham Voice on Use of Gaming Revenues" (the "Initiative"), which authorizes
9 per capita payments to the Nation's members provided that sufficient gaming
10 revenues are available; and
11 **WHEREAS,** the Ordinance for the Regulation of Gaming Activities Within the Tohono
12 O'odham Nation ("Gaming Ordinance") was subsequently amended to authorize
13 per capita distribution payments in accordance with the Initiative (Legislative
14 Council Resolution No. 97-303); and
15 **WHEREAS,** the Trust Agreement with Principal Trust Company requires that a listing of all
16 minor beneficiaries turning 18 that month be presented to the Tohono O'odham
17 Legislative Council to obtain approval to distribute the trust funds to these
18 eligible minor members as they are no longer restricted beneficiaries; and
19 **WHEREAS,** by Resolution Nos. 20-068 and 24-156, the Tohono O'odham Legislative Council
20 approved the Monthly Age 18 Reports for March 2020 and June 2024 of eligible
21 minor members who reached the age of 18 and are no longer restricted from
22 receiving their per capita payments; and
23 **WHEREAS,** the Nation's Enrollment Office has identified incorrect names and/or dates of
24 birth for members on the Monthly Age 18 Reports for March 2020 and June 2024;
25 and
26 **WHEREAS,** the Nation's Enrollment Office recommends that the names and/or dates of birth
27 of members be amended in accordance with the Monthly Age 18 Report
28 Amendment Summary for August 2024, which is incorporated by this reference;

30 **WHEREAS,** the Rules Committee has reviewed the Enrollment Office's recommendations
31 and recommends approval.

1 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves
2 amending the Monthly Age 18 Report for March 2020, approved by Resolution No.
3 20-068, and the Monthly Age 18 Report for June 2024, approved by Resolution No.
4 24-156, to correct names and/or dates of birth of members in accordance with the
5 attached Monthly Age 18 Report Amendment Summary for August 2024.

6 **BE IT FINALLY RESOLVED** that the Tohono O'odham Legislative Council authorizes Principal
7 Trust Company to commence payment to the non-restricted beneficiaries listed
8 on the Monthly Age 18 Report Amendment Summary for August 2024, subject to
9 the additional requirements of the Trust Agreement and written confirmation of
10 the beneficiary's current mailing address and other information.

11 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH
12 day of AUGUST 2024 at a meeting at which a quorum was present with a vote of 3,263.3 FOR; -0-
13 AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by
14 Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the
15 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
16 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
17 18, 1934 (48 Stat.984).




