5	WHEREAS,	the Tohono O'odham Nation's Elections law, codified at 12 Tohono O'odham Code					
6		Chapter 1, anthorizes the Tohono O'odham Legislative Council to appoint five					
7		bilingual members of the Tohono O'odham Nation to the Nation's Election Board					
8		(12 T.O.C. Chapter 1, Article III, Section 1301(A) and (B)); and					
9	WHEREAS,	the Nation's Elections law provides that Election Board members shall be					
10		"appointed for a term of five years or until their successors are appointed" and					
11		further that "[a]ppointments to the [Election] Board shall be staggered so that the					
12		term of office of only one member will end in any single year" (12 T.O.C. Chapter					
13		1, Article III, Section 1301(B)); and					
14	WHEREAS,	Geneva Acosta was appointed to the Election Board by Resolution No. 19-454 for a					
15		term ending July 31, 2024, and she continues to serve until her successor is					
16		appointed; and					
17	WHEREAS,	the Rules Committee recommends that Geneva Acosta be appointed to the					
18		Election Board for a term ending July 31, 2029.					
19	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council appoints						
20		Geneva Acosta to the Election Board for a term beginning on the effective date of					
21	this resolution and ending July 31, 2029, provided that she shall continue to serve						
22		until her successor is appointed.
