

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Setting August 22, 2024 Special Session for the Phase II Legislative Branch Audit Report)**

LEGISLATIVE ORDER NO. 24-229

1 **WHEREAS,** the Legislative Council is vested with the power to “establish rules and
2 procedures to regulate all meetings of the Tohono O’odham Council, standing
3 committees, boards and special committees.” (Constitution of the Tohono
4 O’odham Nation, Article VI, Section 1(a)); and

5 **WHEREAS,** the Legislative Rules of the Tohono O’odham Legislative Council vest the Council
6 with the authority to “by majority vote, call for a special session” (Legislative
7 Rules of the Tohono O’odham Legislative Council, Article I, Section 1.D.1.); and


8 **WHEREAS,** Article I, Section 2(C) of the Legislative Rules of the Tohono O’odham Legislative
9 Council provides that “All Legislative Council sessions shall be held at the Tohono
10 O’odham Legislative Council chambers located in Sells, Tohono O’odham Nation,
11 with the following exceptions . . . [a] majority of all the legislative representatives
12 may vote to hold a session in some location other than the chambers located at
13 Sells.”; and

14 **WHEREAS,** the Legislative Council officers are requesting a special session be set on August
15 22, 2024 for the Phase II Legislative Branch Audit Report.

16 **NOW, THEREFORE, BE IT ORDERED** by the Tohono O’odham Legislative Council that it sets a
17 special session on August 22, 2024, to be held in San Xavier District at a location
18 to be determined by the Council chairperson, for the Phase II Legislative Branch
19 Audit Report with roll call beginning at 10:00 a.m.


20 The foregoing Order was passed by the Tohono O’odham Legislative Council on the 05TH day of
21 AUGUST, 2024 at a meeting at which a quorum was present with a vote of 3,263.3 FOR; -0-
22 AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by
23 Article VI, Section 1(a) of the Constitution of the Tohono O’odham Nation, adopted by the
24 Tohono O’odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
25 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
26 18, 1934 (48 Stat.984).
