

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Hewel Ni'ok KOHN Corporation for Public Broadcasting Community
Service Grant American Rescue Plan Act Stabilization Budget Amendment No. 4)**

RESOLUTION NO. 24-235

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Hewel Ni'ok KOHN Corporation for Public Broadcasting ("CPB") Community**
8 **Service Grant ("CSG") American Rescue Plan Act ("ARPA") Stabilization Budget in**
9 **the amount of \$115,823.55 was approved by Resolution No. 21-458, amended by**
10 **Resolution No. 22-225, decreasing the original budget from \$115,823.55 to**
11 **\$107,963.31, amended further by Resolution No. 23-309, increasing the budget**
12 **from \$107,963.31 to \$257,960.19 and Resolution 24-063, adjusting operational**
13 **and/or personnel line items, approved amendment 3, decreasing the budget**
14 **from \$257,960.19 to \$257,544.36; and**

15 **WHEREAS, the Hewel Ni'ok has prepared and submitted for review and approval its FY 2024**
16 **CSG ARPA Stabilization Budget Amendment No. 4, which is incorporated by this**
17 **reference, and which will adjust personnel, operational and indirect cost; and**

18 **WHEREAS, the FY 2024 Hewel Ni'ok KOHN CPB CSG ARPA Stabilization Budget Amendment**
19 **No. 4 will increase the FY 2024 Hewel Ni'ok CPB CSG ARPA Stabilization Budget by**
20 **\$1,379.98, from \$ 257,544.36 to \$258,924.34; and**

21 **WHEREAS, the Cultural Preservation and Budget and Finance Committees have reviewed the**
22 **FY 2024 Hewel Ni'ok KOHN CPB CSG ARPA Stabilization Budget Amendment No. 4**
23 **and recommend its approval.**

24 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
25 **FY 2024 Hewel Ni'ok KOHN CPB CSG ARPA Stabilization Budget Amendment No. 4**
26 **effective October 1, 2023, which increases the budget amount by \$1,379.98, from**
27 **\$257,544.36 to \$258,924.34, and that shall be funded by the Hewel Ni'ok KOHN CPB**
28 **Community Service ARPA Stabilization Grant.**

29 **BE IT FURTHER RESOLVED that Hewel Ni'ok KOHN CPB CSG ARPA Stabilization Budget funds are**
30 **authorized until the grant funds are fully expended to provide continued**
31 **services.**



3 expend the FY 2024 Hewel Ni'ok KOHN CPB CSG ARPA Stabilization Budget as
4 amended, provided that any amendments or modifications shall be submitted
5 for prior approval by the Tohono O'odham Legislative Council.

6 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH
7 day of AUGUST 2024 at a meeting at which a quorum was present with a vote of 3,263.3 FOR; -0-
8 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by
9 Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by
10 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
11 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
12 18, 1934 (48 Stat.984).




