12	WHEREAS,	the FY 2024 Baboquivari District Administration Budget in the amount of
13		\$5,373,205.73 was authorized by Baboquivari District Resolution No. 2023-B-93
14		and approved by Legislative Council Resolution No. 23-368 and subsequently
15		amended by Resolution No. 24-209; and
16	WHEREAS,	by Baboquivari District Council Resolution No. 2024-B-70, the Baboquivari
17		District has authorized and submitted for review and approval its FY 2024
18		Baboquivari District Administration Budget Amendment No. 1, which is
19		incorporated by this reference and which will adjust personnel and/or
20		operational line items; and
21	WHEREAS,	the FY 2024 Baboquivari District Administration Budget Amendment No. 1 will
22		not change the FY 2024 Baboquivari District Administration Budget amount of
23		\$1,605,961.71; and
24	WHEREAS,	the Budget and Finance Committee has reviewed the FY 2024 Baboquivari District
25		Administration Budget Amendment No. 1 and recommends its approval.
26	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
27		FY 2024 Baboquivari District Administration Budget Amendment No. 1, effective
28		October 1, 2023, which will not change the FY 2024 Baboquivari District
29		Administration Budget amount of \$1,605,961.71 nor will it change the FY 2024
30		Baboquivari District Budget amount of \$5,373,205.73.
