

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2024 Advocate Program Budget Amendment No. 1)**

RESOLUTION NO. 24-256

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2024 Advocate Program's original budget in the amount of \$3,012,654.24**
8 **was approved by Resolution No. 23-192; and**

9 **WHEREAS, the Advocate Program has prepared and submitted for review and approval its FY**
10 **2024 Budget Amendment No. 1, which is incorporated by this reference and which**
11 **will adjust operational and/or personnel line items; and**

12 **WHEREAS, the FY 2024 Advocate Program Budget Amendment No. 1 will decrease the FY 2024**
13 **Advocate Program Budget by \$99,968.19 from \$3,012,654.24 to \$ 2,912,686.05; and**

14 **WHEREAS, the Domestic Affairs and the Budget and Finance Committees have reviewed the**
15 **FY 2024 Advocate Program Budget Amendment No. 1 and recommend its**
16 **approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
18 **FY 2024 Advocate Program Budget Amendment No. 1, which includes a \$99,968.19**
19 **decrease from \$3,012,654.24 to \$2,912,686.05 that shall be funded by the Nation's**
20 **general fund.**


21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
22 **Nation chairperson or any designated official is authorized to administer and**
23 **expend the FY 2024 Advocate Program Budget as amended, provided that any**
24 **amendments or modifications shall be submitted for prior approval by the**
25 **Tohono O'odham Legislative Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22ND**
27 **day of AUGUST 2024 at a meeting at which a quorum was present with a vote of 3,263.3 FOR; -0-**
28 **AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by**
29 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**
30 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
32 **18, 1934 (48 Stat.984).**


