

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving to amend existing Public Law 93-638 A23AV00307, Project PIR 1(5)
to change the Scope of Work)

RESOLUTION NO. 24-258

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, Legislative Council adopted the FY 2022-2026 Trihal Transportation**
8 **Improvement Plan Funding and Trihal Priority List ("22-26 TTIP Funding & Trihal**
9 **Priority List") and its subsequent amendments through Res. No. 22-155, Res. No.**
10 **22-208 and Res. No. 23-128; and**

11 **WHEREAS, the Department of Planning & Economic Development ("Department") Roads**
12 **Program submitted a request to the Bureau of Indian Affairs to change the**
13 **Menegers Dam Road, BIA Route 1 Road Project ("Menegers Dam Project") from a**
14 **Design Only Project to a Design and Road Construction Project; and**

15 **WHEREAS, the Roads Program is currently exploring funding opportunities for the Menegers**
16 **Dam Project to increase its current allocation, including funds that may be**
17 **obligated from the United States Border Patrol; and**

18 **WHEREAS, the Roads Program requests Legislative Council amend the existing Public Law**
19 **93-638 A23AV00307, Project PIR 1(5) to change the Scope of Work to reflect the**
20 **designation of Design and Road Construction Project; and**

21 **WHEREAS, the Agricultural and Natural Resources Committee reviewed Amendment to**
22 **Public Law 93-638 A23AV00307, Project PIR 1(5) and recommend its approval.**

23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
24 **Amendment to the Public Law 93-638 A23AV00307, Project PIR 1(5) to change the**
25 **Scope of Work to reflect Design and Road Construction Project.**

26 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council hereby authorizes the**
27 **Tohono O'odham Nation chairperson or any designated official to expend and**
28 **administer the budget, as attached, provided that any amendments or**
29 **modifications shall be submitted for prior approval by the Tohono O'odham**
30 **Legislative Council.**


