**RESOLUTION NO. ~~24-260~~**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**  
2 **and ordinances governing the enrollment and adoption of members**  
3 **(Constitution of the Tohono O'odham Nation, Article II, Sections 1 and 2 and**  
4 **Article VI, Section 1(h)); and**

5 **WHEREAS, pursuant to Article VI and VII of the Nation's Enrollment Ordinance, the**  
6 **Enrollment Committee shall review membership applications and make a**  
7 **written recommendation to the Tohono O'odham Legislative Council to approve**  
8 **or reject the application (14 Tohono O'odham Code Chapter 1 - Enrollment**  
9 **Ordinance); and**

10 **WHEREAS, pursuant to Article VIII of the Nation's Enrollment Ordinance, the Tohono**  
11 **O'odham Legislative Council shall determine eligibility for membership or**  
12 **adoption; and**

13 **WHEREAS, the Enrollment Program has received official documents reflecting the legal**  
14 **name changes of enrolled members as a result of marriage, divorce, legal**  
15 **adoption, or for other reasons; and**

16 **WHEREAS, the Enrollment Committee recommends that Resolution Nos. 15-80, 127-83, 96**  
17 **547, 99-475, 99-633, 00-035, 07-362, 07-546, 19-128 and 22-417 be amended to**  
18 **reflect the legal names changes of members identified in the September 2024**  
19 **Amended Enrollment Resolution Summary, which is incorporated by this**  
20 **reference.**

21 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that Resolution**  
22 **Nos. 15-80, 127-83, 96-547, 99-475, 99-633, 00-035, 07-362, 07 546, 19-128 and 22-**  
23 **417 are amended upon the effective date of those resolutions to reflect the legal**  
24 **name changes of members identified in the September 2024 Amended**  
25 **Enrollment Resolution Summary.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09<sup>TH</sup>**  
27 **day of SEPTEMBER 2024 at a meeting at which a quorum was present with a vote of 3,263.3 FOR;**  
28 **~~0~~ AGAINST; ~~0~~ NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
29 **Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono O'odham**  
30 **Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**  
31 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**  
32 **16 of the Act of June 18, 1934 (48 Stat.984).**


