

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Agreement Between the Tohono O'odham Legislative Branch and
Axios Builders LLC)**

RESOLUTION NO. 24-264

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with**
2 **the power to “negotiate and conclude agreements and contracts on behalf of the**
3 **Tohono O'odham Nation... with private persons or organizations on all matters**
4 **within the authority of the Tohono O'odham Council” (Constitution, Article VI,**
5 **Section 1(f)); and**

6 **WHEREAS, the Council has prescribed the duties and powers of the Council Chairperson and**
7 **Vice Chairperson (collectively, “legislative officers”) by adopting the Legislative**
8 **Rules and by passing Legislative Order No. 06-047, “Amended Delegation of**
9 **Authority to Legislative Council Chairperson and Vice Chairperson”;** and

10 **WHEREAS, the Legislative Council by Resolution No. 08-707 enacted and codified Title 26,**
11 **Article 4, Section 1405 of the Nation's Code, which vests the Legislative Council**
12 **Chairperson with the authority to negotiate, execute, and conclude contracts that**
13 **expend funds pursuant to appropriations or budgets authorized by resolution,**
14 **that are within the authorities delegated to the Council Chairperson and Vice**
15 **Chairperson by the Legislative Council, and in amounts not to exceed \$100,000;**
16 **and**

17 **WHEREAS, the Legislative Council by Resolution No. 22-311 approved the FY 2022-FY 2025**
18 **Legislative Branch American Rescue Plan Act Budget, which includes funding to**
19 **cover all costs associated with the construction of the Legislative Branch**
20 **replacement building; and**

21 **WHEREAS, the Legislative Council chairperson has selected Axios Builders LLC for the**
22 **demolition of the existing Tohono O'odham Legislative Building; and**

23 **WHEREAS, the Agreement Between the Tohono O'odham Legislative Branch and Axios**
24 **Builders LLC (“the Agreement”), which is incorporated by this reference, is for an**
25 **amount not to exceed \$1,499,718.96 and requires Legislative Council approval;**
26 **and**

27 **WHEREAS, the Legislative Council chairperson has reviewed the Agreement and**
28 **recommends approval.**


29 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
30 **Agreement Between the Tohono O'odham Legislative Branch and Axios Builders**
31 **LLC in substantially the form attached, and in an amount not to exceed**
32 **\$1,499,718.96.**

1 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Agreement shall
2 be funded by the Legislative Branch American Rescue Plan Act Budget approved
3 by Resolution No. 22-311.

4 BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council authorizes the
5 Legislative Council chairperson to execute the Agreement Between the Tohono
6 O'odham Legislative Branch and Axios Builders LLC.


7 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH
8 day of SEPTEMBER 2024 at a meeting at which a quorum was present with a vote of 3,263.3 FOR;
9 -0- AGAINST; [01] NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by
10 Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
11 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
12 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934
13 (48 Stat.984).




