

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Law Enforcement Mutual Aid Agreement Between the Tohono
O'odham Nation and the City of Tucson)**

RESOLUTION NO. 24-265

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "consult,**
2 **negotiate and conclude agreements . . . on behalf of the Tohono O'odham Nation**
3 **with Federal, State and local governments . . . or their departments, agencies, or**
4 **political subdivisions . . . on all matters within the authority of the Tohono**
5 **O'odham Council" and to "promote, protect and provide for public health, peace,**
6 **morals, education and general welfare of the Tohono O'odham Nation and its**
7 **members" (Constitution of the Tohono O'odham Nation, Article VI, Sections l(f)**
8 **and 1(c)(2); and**

9 **WHEREAS, the Tohono O'odham Nation has negotiated a new Law Enforcement Mutual Aid**
10 **Agreement Between the Tohono O'odham Nation and the City of Tucson to**
11 **provide mutual aid and assistance in the field of law enforcement; and**

12 **WHEREAS, the Domestic Affairs Committee has reviewed the Law Enforcement Mutual Aid**
13 **Agreement Between the Tohono O'odham Nation and the City of Tucson and**
14 **recommends its approval.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
16 **Law Enforcement Mutual Aid Agreement Between the Tohono O'odham Nation**
17 **and the City of Tucson.**

18 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
19 **Nation chairperson or any designated official is authorized to execute the Law**
20 **Enforcement Mutual Aid Agreement Between the Tohono O'odham Nation and**
21 **the City of Tucson substantially in the form attached hereto provided that any**
22 **amendments shall be submitted for prior approval by the Tohono O'odham**
23 **Legislative Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH**
25 **day of SEPTEMBER 2024 at a meeting at which a quorum was present with a vote of 3,263.3 FOR;**
26 **-0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
27 **Article VI, Sections 1(c)(2) and (f) of the Constitution of the Tohono O'odham Nation, adopted by**
28 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
30 **18, 1934 (48 Stat.984).**
