

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Amending Resolution No. 23-020 "Approving FY 2024 Tohono O'odham Nation Health Care American Rescue Plan Act Equipment Budget" to extend the Budget Authority into FY 2025)**

**RESOLUTION NO. 24-269**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2) and (3)); and**

7 **WHEREAS, the FY 2022 Tohono O'odham Nation Healthcare American Rescue Plan Act**  
8 **Equipment Budget in the amount of \$328,474.00 was approved by Resolution No.**  
9 **22-140; and**

10 **WHEREAS, the FY 2023 Tohono O'odham Nation Healthcare American Rescue Plan Act**  
11 **Equipment Budget Authority was extended by Resolution No. 23-020; and**

12 **WHEREAS, Tohono O'odham Nation Health Care ("TONHC") has prepared and submitted for**  
13 **review and approval of its FY 2024 Tohono O'odham Nation Health Care American**  
14 **Rescue Plan Act Equipment Budget request to amend Resolution No, 23-020 to**  
15 **extend the budget period ending on September 30, 2025 to allow for available**  
16 **funds to be expended; and**

17 **WHEREAS, TONHC has submitted to the Executive Office and received approval of a**  
18 **ratification to allow an outstanding invoice to be paid; and**

19 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**  
20 **reviewed the FY 2024 Tohono O'odham Nation Health Care American Rescue Plan**  
21 **Act Equipment Budget Amendment and Amending Resolution and recommends**  
22 **approval.**

23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves to**  
24 **extend the Budget authority for the FY 2024 Tohono O'odham Nation Healthcare**  
25 **American Rescue Plan Act Equipment Budget in the amount of \$328,474.00**  
26 **through September 30, 2025.**

27 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
28 **Nation chairperson or any designated official is authorized to administer and**  
29 **expend the FY 2024 Tohono O'odham Nation Health Care American Rescue Plan**  
30 **Act Equipment Budget for the period of October 1, 2023 through September 30,**  
31 **2025 and the Accounting Office is authorized to post the unexpended balances of**  
32 **the budget as of September 30, 2023 as a carryforward to FY 2024 beginning**

October 2023, provided that any amendments or modifications shall be submitted for prior approval by the Tohono O'odham Legislative Council.
