

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2024-FY 2025 Executive Branch Get Out the Vote Budget)**

**RESOLUTION NO. 24-270**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** to educate, inform, and ultimately increase voter turnout on Election Day, the  
8 Office of the Chairman has prepared and submitted for review and approval its  
9 FY 2024 - FY 2025 Executive Branch Get Out the Vote Budget which is incorporated  
10 by this reference, in the amount of \$50,000.00 with an effective date of October 1  
11 2023, through September 30, 2025 to be funded by the general fund surplus; and


12 **WHEREAS,** the Rules and Budget and Finance Committees have reviewed the FY 2024-FY 2025  
13 Executive Branch Get Out the Vote Budget and recommend its approval.

14 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
15 FY 2024 - FY 2025 Executive Branch Get Out the Vote Budget, effective October 1,  
16 2023 through September 30, 2025 in the amount of \$50,000, which shall be funded  
17 by the general fund surplus.

18 **BE IT FINALLY RESOLVED** that the Tohono O'odham Legislative Council hereby authorizes the  
19 Chairperson and any designated official to expend and administer the budget as  
20 attached, provided that any modification/amendments affecting the funds or  
21 funding level is submitted for prior approval by the Tohono O'odham Legislative  
22 Council.

23 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10<sup>TH</sup>  
24 day of SEPTEMBER 2024 at a meeting at which a quorum was present with a vote of 3,263.3 FOR;  
25 -0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by  
26 Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by  
27 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
28 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
29 18, 1934 (48 Stat.984).






