

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2024-FY 2025 Cities Forward and Tribes Forward "Get Out the Vote" Budget)

RESOLUTION NO. 24-271

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** Cities Forward and Tribes Forward has awarded funding for the project period of
8 two years beginning October 1, 2023 and ending September 30, 2025 and the
9 Executive Office has prepared Cities Forward and Tribes Forward "Get Out the
10 Vote" budget to expend funds for the budget period; and

11 **WHEREAS,** the Executive Office has prepared and submitted for review and approval its FY
12 2024-FY 2025 Cities Forward and Tribes Forward "Get Out the Vote" budget, which
13 is incorporated by this reference, in the amount of \$25,000.00 to be funded from
14 Cities Forward and Tribes Forward of which \$20,000.00 is to be allocated to the
15 Nation and \$5,000.00 to the Nation's Youth Council to be used in public relations;
16 and

17 **WHEREAS,** the Rules and Budget and Finance Committees have reviewed the FY 2024-FY 2025
18 Cities Forward and Tribes Forward "Get Out the Vote" budget and recommend its
19 approval.

20 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
21 FY 2024-FY 2025 Cities Forward and Tribes Forward "Get Out the Vote" budget
22 effective October 1, 2023 ending September 30, 2025 in the amount of \$25,000.00,
23 which shall be funded by the Nation's general fund pending reimbursement from
24 Cities Forward and Tribes Forward.

25 **BE IT FURTHER RESOLVED** by the Legislative Council that the \$25,000.00 budgeted amount for
26 Cities Forward and Tribes Forward will be allocated as follows: \$20,000.00 to the
27 Nation; and \$5,000.00 to the Nation's Youth Council, to be used for public
28 relations.

29 **BE IT FINALLY RESOLVED** that the Tohono O'odham Legislative Council hereby authorizes the
30 Tohono O'odham Nation chairperson or any designated official to expend and
31 administer the budget, as attached, provided that any amendments or
32 modifications shall be submitted for prior approval by the Tohono O'odham
33 Legislative Council.




