9		on a Legislative Council committee may be filled by seniority preference,
10		provided that a representative's transfer from another committee shall not
11		require a change in a committee's assigned meeting day. Thereafter, any
12		remaining vacancies shall be filled by the representative's successor in office.";

14	WHEREAS,	there are currently vacancies on the Human Resources Development, Domestic
15		Affairs, and Water Resources Committees; and
16	WHEREAS,	in accordance with Legislative Rules, Article XII, Section 3(L)(2), Council
17		representatives were given the opportunity, based npon seniority, to change
18		committee assignments in a manner that does not alter the meeting dates
19		approved in the 2023-2025 Legislative Council Committee Meeting Schedule
20		adopted by Legislative Order No. 23-327; and
21	WHEREAS,	Representative Francis Homewytewa shall fill the remaining vacancies on the
22	i	Human Resources Development, Domestic Affairs, and Water Resources

24	NOW, THERI	FORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it appoints
25		Representative Francis Homewytewa to the Human Resources Development,
