

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2025 Department of Education One Stop Division Public Law 102-477 Budget)

RESOLUTION NO. 24-283

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Education has prepared and submitted for review and**
8 **approval its FY 2025 One Stop Division Public Law 102-477 Budget, which is**
9 **incorporated by this reference, in the amount of \$1,141,042.67 to be funded by the**
10 **Nation's general fund pending reimbursement from the grantor, Bureau of**
11 **Indian Affairs Public Law 102-477 Grant; and**

12 **WHEREAS, the Human Resources Development and Budget and Finance Committees have**
13 **reviewed the FY 2025 Department of Education One Stop Division Public Law 102-**
14 **477 Budget and recommend its approval.**


15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
16 **FY 2025 Department of Education One Stop Division Public Law 102-477 Budget**
17 **effective October 1, 2024 in amount of \$1,141,042.67, which shall be funded by the**
18 **Nation's general fund pending reimbursement from the grantor, Bureau of**
19 **Indian Affairs Public Law 102-477 Grant.**

20 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
21 **Nation chairperson or any designated official is authorized to administer and**
22 **expend the FY 2025 Department of Education One Stop Division Public Law 102-**
23 **477 Budget, provided that any amendments or modifications shall be submitted**
24 **for prior approval by the Tohono O'odham Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16TH**
26 **day of SEPTEMBER 2024 at a meeting at which a quorum was present with a vote of 3,263.3 FOR;**
27 **-0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
28 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
29 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
31 **18, 1934 (48 Stat.984).**






