

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2025 Planning and Economic Development Department  
Realty Program Land Acquisition Budget)**

**RESOLUTION NO. 24-289**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Planning and Economic Development Department has prepared and**  
8 **submitted for review and approval its FY 2025 Realty Program Land Acquisition**  
9 **Budget, which is incorporated by this reference, in the amount of \$480,000.00 to**  
10 **be funded from the Nation's Land Acquisition Fund; and**

11 **WHEREAS, the Agricultural and Natural Resources and Budget and Finance Committees**  
12 **have reviewed the FY 2025 Planning and Economic Development Department**  
13 **Realty Program Land Acquisition Budget and recommend its approval.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
15 **FY 2025 Planning and Economic Development Department Realty Program Land**  
16 **Acquisition Budget effective October 1, 2024, in the amount of \$480,000.00 which**  
17 **shall be funded by the Nation's Land Acquisition Fund.**

18 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
19 **Nation chairperson or any designated official is authorized to administer and**  
20 **expend the FY 2025 Planning and Economic Development Department Realty**  
21 **Program Land Acquisition Budget, provided that any amendments or**  
22 **modifications shall be submitted for prior approval by the Tohono O'odham**  
23 **Legislative Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16<sup>TH</sup>**  
25 **day of SEPTEMBER 2024 at a meeting at which a quorum was present with a vote of 3,263.3 FOR;**  
26 **-0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
27 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**  
28 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
30 **18, 1934 (48 Stat.984).**
