

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2025 Department of Natural Resources Solid Waste Management  
Program Revenue Funding Budget)**

**RESOLUTION NO. 24-297**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Natural Resources has prepared and submitted for review and**  
8 **approval its FY 2025 Solid Waste Management Program Revenue Funding Budget,**  
9 **which is incorporated by this reference, in the amount of \$2,356,317.07 of which**  
10 **\$2,056,317.07 is to be funded from the Nation's General Fund; and \$300,000.00 is**  
11 **to be funded by program revenues; and**

12 **WHEREAS, the portion of the FY 2025 Department of Natural Resources Solid Waste**  
13 **Management Budget funded from the Nation's general fund is addressed by**  
14 **separate resolution; and**

15 **WHEREAS, the Agricultural and Natural Resources and Budget and Finance Committees**  
16 **have reviewed the FY 2025 Department of Natural Resources Solid Waste**  
17 **Management Program Revenue Funding Budget and recommend its approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
19 **FY 2025 Department of Natural Resources Solid Waste Management Program**  
20 **Revenue Funding Budget effective October 1, 2024, in the amount of \$300,000.00,**  
21 **which shall be funded by program revenues.**

22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
23 **Nation chairperson or any designated official is authorized to administer and**  
24 **expend the FY 2025 Department of Natural Resources Solid Waste Management**  
25 **Program Revenue Funding Budget, provided that any amendments or**  
26 **modifications shall be submitted for prior approval by the Tohono O'odham**  
27 **Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16<sup>TH</sup>**  
29 **day of SEPTEMBER 2024 at a meeting at which a quorum was present with a vote of 3,263.3 FOR;**  
30 **-0- AGAINST; [01] NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
31 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**  
32 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
34 **18, 1934 (48 Stat.984).**
