

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2025 Department of Natural Resources Tribal Historic  
Preservation Office Budget)**

**RESOLUTION NO. 24-300**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Natural Resources has prepared and submitted for review and**  
8 **approval its FY 2025 Department of Natural Resources Tribal Historic**  
9 **Preservation Office Budget, which is incorporated by this reference, in the**  
10 **amount of \$147,378.00, to be funded by the Nation's general fund pending**  
11 **reimbursement from the grantor, the U.S. Department of the Interior National**  
12 **Park Service; and**

13 **WHEREAS, the Cultural Preservation and Budget and Finance Committees have reviewed the**  
14 **FY 2025 Department of Natural Resources Tribal Historic Preservation Office**  
15 **Budget and recommend its approval.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
17 **FY 2025 Department of Natural Resources Tribal Historic Preservation Office**  
18 **Budget effective October 1, 2024, in the amount of \$147,378.00, which shall be**  
19 **funded by the Nation's general fund pending reimbursement from the grantor,**  
20 **the U.S. Department of the Interior National Park Service.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
22 **Nation chairperson or any designated official is authorized to administer and**  
23 **expend the FY 2025 Department of Natural Resources Tribal Historic**  
24 **Preservation Office Budget, provided that any amendments or modifications**  
25 **shall be submitted for prior approval by the Tohono O'odham Legislative Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16<sup>TH</sup>**  
27 **day of SEPTEMBER 2024 at a meeting at which a quorum was present with a vote of 3,263.3 FOR;**  
28 **-0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
29 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**  
30 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
32 **18, 1934 (48 Stat.984).**
