

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2025 Department of Public Safety Environmental Protection  
Office Brownfields Budget)**

**RESOLUTION NO. 24-304**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Public Safety has prepared and submitted for review and**  
8 **approval its FY 2025 Environmental Protection Office Brownfields Budget, which**  
9 **is incorporated by this reference, in the amount of \$187,000.00 to be funded by**  
10 **the Nation's general fund pending reimbursement from the U.S. Environmental**  
11 **Protection Agency Assistance Agreement Grant under the Brownfields 128(a)**  
12 **Tribal Response Program; and**

13 **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed the FY**  
14 **2025 Department of Public Safety Environmental Protection Office Brownfields**  
15 **Budget and recommend its approval.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
17 **FY 2025 Department of Public Safety Environmental Protection Office**  
18 **Brownfields Program Budget effective October 1, 2024 in the amount of**  
19 **\$187,000.00 which shall be funded by the Nation's general fund pending**  
20 **reimbursement from the grantor, U.S. Environmental Protection Agency.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
22 **Nation chairperson or any designated official is authorized to administer and**  
23 **expend the FY 2025 Department of Public Safety Environmental Protection Office**  
24 **Brownfields Program Budget as amended, provided that any amendments or**  
25 **modifications shall be submitted for prior approval by the Tohono O'odham**  
26 **Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16<sup>TH</sup>**  
28 **day of SEPTEMBER 2024 at a meeting at which a quorum was present with a vote of 3,263.3 FOR;**  
29 **-0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
30 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**  
31 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
33 **18, 1934 (48 Stat.984).**
