

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2025 Department of Health and Human Services Division of Health
Transportation Service Program Revenue Funding Budget)**

RESOLUTION NO. 24-305

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for
8 review and approval its FY 2025 Division of Health Transportation Service
9 Program Revenue Funding Budget, which is incorporated by this reference, in the
10 amount of \$4,705,659.00 of which \$4,154,635.00, to be funded from the Nation's
11 General Fund of which \$442,976.39 is one time funding; and \$494,774.00 is funded
12 program revenues and \$56,250.00 is funded from miscellaneous revenues; and

13 **WHEREAS,** the portion of the FY 2025 Department of Health and Human Services Division of
14 Health Transportation Service Budget to be funded from the Nation's general
15 fund is addressed by separate resolution; and

16 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
17 reviewed the FY 2025 Department of Health and Human Services Division of
18 Health Transportation Service Program Revenue Funding Budget and
19 recommend its approval.

20 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
21 **FY 2025 Department of Health and Human Services Division of Health**
22 **Transportation Service Program Revenue Funding Budget effective October 1,**
23 **2024 in the amount of \$4,705,659.00 of which \$4,154,635.00 to be funded from the**
24 **Nation's General Fund, and \$494,774.00 which shall be funded by Health**
25 **Transportation Service program revenues and \$56,250.00 which shall be funded**
26 **by miscellaneous revenues**

27 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
28 **Nation chairperson or any designated official is authorized to administer and**
29 **expend the FY 2025 Department of Health and Human Services Division of Health**
30 **Transportation Service Program Revenue Funding Budget, provided that any**
31 **amendments or modifications shall be submitted for prior approval by the**
32 **Tohono O'odham Legislative Council.**





6 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
7 18, 1934 (48 Stat.984).




