11		program revenues; and
12	WHEREAS,	the portion of the FY 2025 Department of Health and Human Services Elders Day
13		Program Revenue Budget funded from the Nation's General Fund is addressed by
14		separate resolution; and
15	WHEREAS,	the Health and Human Services and Budget and Finance Committees have
16		reviewed the FY 2025 Department of Health and Human Services Elders Day
17		Program Revenue Budget and recommend its approval.
18	NOW, THERI	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
19		FY 2025 Department of Health and Human Services Elders Day Program Revenue
20		Budget effective October 1, 2024 in the amount of \$3,000.00, which shall be funded
21		by program revenues.

23		Nation chairperson or any designated official is authorized to administer and
24		expend the FY 2025 Department of Health and Human Services Elders Day

26		he submitted for prior approval by the Tohono O'odham Legislative Council.
