

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2025 Department of Health and Human Services Division of  
Behavioral Health Tas Tonlik Ki: Program Budget)**

**RESOLUTION NO. 24-307**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Health and Human Services has prepared and submitted for**  
8 **review and approval its FY 2025 Behavioral Health Tas Tonlik Ki: Program**  
9 **Budget, which is incorporated by this reference, in the amount of \$2,772,098.00 to**  
10 **be funded from program revenues; and**

11 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**  
12 **reviewed the FY 2025 Department of Health and Human Services Division of**  
13 **Behavioral Health Tas Tonlik Ki: Program Budget and recommend its approval.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
15 **FY 2025 Department of Health and Human Services Division of Behavioral Health**  
16 **Tas Tonlik Ki: Program Budget effective October 1, 2024 in amount of**  
17 **\$2,772,098.00, which shall be funded by program revenues.**

18 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
19 **Nation chairperson or any designated official is authorized to administer and**  
20 **expend the FY 2025 Department of Health and Human Services Division of**  
21 **Behavioral Health Tas Tonlik Ki: Program Budget, provided that any**  
22 **amendments or modifications shall be submitted for prior approval by the**  
23 **Tohono O'odham Legislative Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16<sup>TH</sup>**  
25 **day of SEPTEMBER 2024 at a meeting at which a quorum was present with a vote of 3,263.3 FOR;**  
26 **-0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
27 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**  
28 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
30 **18, 1934 (48 Stat.984).**
