

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2025 Department of Health and Human Services Women,  
Infants, and Children Program Inter Tribal Council of Arizona Grant Budget)**

**RESOLUTION NO. 24-311**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for  
8 review and approval its FY 2025 Women, Infants, and Children ("WIC") Program  
9 Grant Budget, which is incorporated by this reference, in the amount of  
10 \$200,000.00 to be funded by the Nation's general fund pending reimbursement by  
11 the grantor, the Inter Tribal Council of Arizona; and

12 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have  
13 reviewed the FY 2025 Department of Health and Human Services WIC Program  
14 Inter Tribal Council of Arizona Grant Budget and recommend its approval.

15 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
16 FY 2025 Department of Health and Human Services WIC Program Inter Tribal  
17 Council of Arizona Grant Budget effective October 1, 2024 in amount of  
18 \$200,000.00, which shall be funded by the Nation's general fund pending  
19 reimbursement by the grantor, the Inter Tribal Council of Arizona.

20 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
21 Nation chairperson or any designated official is authorized to administer and  
22 expend the FY 2025 Department of Health and Human Services WIC Program  
23 Inter Tribal Council of Arizona Grant Budget, provided that any amendments or  
24 modifications shall be submitted for prior approval by the Tohono O'odham  
25 Legislative Council.

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16<sup>TH</sup>**  
27 **day of SEPTEMBER 2024 at a meeting at which a quorum was present with a vote of 3,263.3 FOR;**  
28 **-0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
29 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**  
30 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
32 **18, 1934 (48 Stat.984).**
