

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2025 Tohono O'odham Nation Health Care Budgets)**

RESOLUTION NO. 24-312

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Tohono O'odham Nation Health Care have prepared and submitted for review
8 and approval its FY 2025 Tohono O'odham Nation Health Care Budgets
9 (collectively, "FY 2025 Tohono O'odham Nation Health Care Budgets") and as
10 identified in FY 2025 Tohono O'odham Nation Health Care Budgets Schedule,
11 which is attached and incorporated by this reference, in the total amount of
12 \$150,500,365.98; and

17 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
18 reviewed the FY 2025 Tohono O'odham Nation Health Care Budgets and
19 recommend their approval.


20 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
21 FY 2025 Tohono O'odham Nation Health Care Budgets effective October 1, 2024 in
22 the total amount of \$150,500,365.98, which shall be funded by the Indian Health
23 Service and third party revenues.

24 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
25 Nation chairperson or any designated official is authorized to administer and
26 expend the FY 2025 Tohono O'odham Nation Health Care Budgets, provided that
27 the Governing Body shall approve any amendments or modifications, subject to
28 final approval by the Tohono O'odham Legislative Council.



2 day of SEPTEMBER 2024 at a meeting at which a quorum was present with a vote of 3,263.3 FOR;
3 -0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by
4 Article VI Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by
5 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
6 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
7 18, 1934 (48 Stat.984).




