

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2025 Tribal Employment Rights Commission Budget)**

RESOLUTION NO. 24-315

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Tribal Employment Rights Commission has prepared and submitted for**
8 **review and approval its FY 2025 Tribal Employment Rights Commission ("TERO**
9 **Commission") Budget, which is incorporated by this reference, in the amount of**
10 **\$129,764.06 to be funded from the TERO Commission Fees revenue; and**


11 **WHEREAS, the Human Resources Development and Budget and Finance Committees have**
12 **reviewed the FY 2025 TERO Commission Budget and recommend its approval.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
14 **FY 2025 TERO Commission Budget effective October 1, 2024 in the amount of**
15 **\$129,764.06 which shall be funded by the TERO Commission Fees revenue.**

16 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
17 **Nation chairperson or any designated official is authorized to administer and**
18 **expend the FY 2025 TERO Commission Budget, provided that any amendments or**
19 **modifications shall be submitted for prior approval by the Tohono O'odham**
20 **Legislative Council.**


21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 18TH**
22 **day of SEPTEMBER 2024 at a meeting at which a quorum was present with a vote of 3,263.3 FOR;**
23 **-0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
24 **Article VI Section 1 (d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**
25 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
27 **18, 1934 (48 Stat.984).**
