

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2025 Gu Achi District Budget Amendment No. 1)**

RESOLUTION NO. 24-316

1 **WHEREAS, pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham**
2 **Nation,**

3 **No district council shall expend district funds except pursuant to budgets**
4 **authorized under resolutions of the district council and approved by the**
5 **Tohono O'odham Council. The management of these funds shall be only by**
6 **a treasurer or other authorized officer of the district council who has**
7 **furnished a surety bond satisfactory to the treasurer of the Tohono**
8 **O'odham Nation, and all expenditures of these funds shall be by checks**
9 **signed by such treasurer or other authorized officer and the chairman or**
10 **vice chairman of the district council.**

12 **WHEREAS, the FY 2025 Gu Achi District Budget in the amount of \$5,373,205.73 was authorized**
13 **by Gu Achi District Council Resolution No. 0524-078 and approved by Legislative**
14 **Council Resolution No. 24-192; and**

15 **WHEREAS, by Gu Achi District Council Resolution No. 0824-101, the Gu Achi District has**
16 **authorized and submitted for review and approval its FY 2025 Gu Achi District**
17 **Budget Amendment No. 1, which is incorporated by this reference; and**

18 **WHEREAS, the FY 2025 Gu Achi District Budget Amendment No. 1 will not increase the budget**
19 **amount of \$5,373,205.73 but supplements funding for the FY 2025 Gu Achi District**
20 **Budget with funds from the Gu Achi District Savings Account in the amount of**
21 **\$637,595.40 to cover the shortfall in the amount approved for the FY 2025 Gu Achi**
22 **District Budget by Resolution No. 24-192 and the Gu Achi District's August 2024**
23 **District Gaming Allocation apportionment approved by Resolution No. 24-218;**
24 **and**

25 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2025 Gu Achi District**
26 **Budget Amendment No. 1 and recommends its approval.**

27 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
28 **FY 2025 Gu Achi District Budget Amendment No. 1 effective October 1, 2024, which**
29 **will not change the FY 2025 Gu Achi District Budget amount of \$5,373,205.73, and**
30 **which shall be funded by:**

31 **(1) August 2024 District Gaming Allocation in the amount of \$4,735,610.33;**



33 **(2) Gu Achi District Savings Account funds in the amount of \$637,595.40.**

1 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2025 Gu Achi
2 **District Budget as amended shall be managed and expended in accordance with**
3 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and the**
4 **Nation's laws, provided that any amendments or modifications shall be**
5 **authorized under District Council resolution and submitted for prior approval by**
6 **the Tohono O'odham Legislative Council.**


7 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 18TH**
8 **day of SEPTEMBER 2024 at a meeting at which a quorum was present with a vote of 3,263.3 FOR;**
9 **-0- AGAINST; [01] NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
10 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
11 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
12 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**
13 **(48 Stat.984).**
