

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2025 San Xavier District Budget)**

RESOLUTION NO. 24-319

1 **WHEREAS, pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham**
2 **Nation,**

3 **No district council shall expend district funds except pursuant to budgets**
4 **authorized under resolutions of the district council and approved by the**
5 **Tohono O'odham Council. The management of these funds shall be only by**
6 **a treasurer or other authorized officer of the district council who has**
7 **furnished a surety bond satisfactory to the treasurer of the Tohono**
8 **O'odham Nation, and all expenditures of these funds shall be by checks**
9 **signed by such treasurer or other authorized officer and the chairman or**
10 **vice chairman of the district council.**

12 **WHEREAS, by San Xavier District Council Resolution No. SXDC 08-24-14, the San Xavier**
13 **District has authorized its FY 2025 San Xavier District Budget, which is**
14 **incorporated by this reference, in the amount of \$13,091,472.44; and**

15 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2025 San Xavier District**
16 **Budget and recommends its approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
18 **FY 2025 San Xavier District Budget effective October 1, 2024 in the amount of**
19 **\$13,091,472.44, which shall be funded by:**

- 20 **1. August 2024 District Gaming Allocation in the amount of \$7,827,179.60;**
- 21 **2. ASARCO Lease Proceeds in the amount of \$6,593.90;**
- 22 **3. Grant funds in the amount of \$2,733,093.71; and**
- 23 **4. District Operating Account funds in the amount of \$2,524,605.23.**

24 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2025 San**
25 **Xavier District Budget shall be managed and expended in accordance with Article**
26 **IX, Section 7 of the Constitution of the Tohono O'odham Nation and the Nation's**
27 **laws, provided that any amendments or modifications shall be authorized under**
28 **District Council resolution and submitted for prior approval by the Tohono**
29 **O'odham Legislative Council.**

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 18TH day of SEPTEMBER 2024 at a meeting at which a quorum was present with a vote of 3,263.3 FOR; -0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
