7		furnished a surety bond satisfactory to the treasurer of the Tohono
8		O'odham Nation, and all expenditures of these funds shall be by checks
9		signed by such treasurer or other authorized officer and the chairman or
10		vice chairman of the district council.

12	WHEREAS,	by San Xavier District Council Resolution No. SXDC 08-24-14, the San Xavier
13		District has authorized its FY 2025 San Xavier District Budget, which is
14		incorporated by this reference, in the amount of \$13,091,472.44; and
15	WHEREAS,	the Budget and Finance Committee has reviewed the FY 2025 San Xavier District
16		Budget and recommends its approval.
17	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
18		FY 2025 San Xavier District Budget effective October 1, 2024 in the amount of
19		\$13,091,472.44, which shall be funded by:
20		1. August 2024 District Gaming Allocation in the amount of \$7,827,179.60;
21		2. ASARCO Lease Proceeds in the amount of \$6,593.90;
22		3. Grant funds in the amount of \$2,733,093.71; and
23		4. District Operating Account funds in the amount of \$2,524,605.23.
24	BE IT FINAL	LY RESOLVED by the Tohono O'odham Legislative Council that the FY 2025 San
25		Xavier District Budget shall be managed and expended in accordance with Article
26		IX, Section 7 of the Constitution of the Tohono O'odham Nation and the Nation's
27		laws, provided that any amendments or modifications shall be authorized under
28		District Council resolution and submitted for prior approval by the Tohono
29		O'odham Legislative Council.
