

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2025 Pisinemo District Operations Budget)**

RESOLUTION NO. 24-321

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only by
6 a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council.

12 **WHEREAS,** by Pisinemo District Council Resolution No. 24-P-31, the Pisinemo District has
13 authorized the FY 2025 Pisinemo District Operations Budget, which is
14 incorporated by this reference in the amount of \$5,373,205.73; and

15 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2025 Pisinemo District
16 Operations Budget and recommends its approval.

17 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
18 FY 2025 Pisinemo District Operations Budget effective October 1, 2024 in the
19 amount of \$5,373,205.73, which shall be funded as follows,

- 20 (1) August 2024 District Gaming Allocation in the amount of \$4,735,610.33;
21 and
22 (2) FY 2023 Pisinemo District Budget carryover funds.

23 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2025 Pisinemo
24 District Operations Budget shall be managed and expended in accordance with
25 Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and the
26 Nation's laws, provided that any amendments or modifications shall be
27 authorized under District Council resolution and submitted for prior approval by
28 the Tohono O'odham Legislative Council.

29 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 18TH
30 day of **SEPTEMBER 2024** at a meeting at which a quorum was present with a vote of **3,263.3 FOR;**
31 **-0- AGAINST; -0- NOT VOTING;** and **[01] ABSENT,** pursuant to the powers vested in the Council by
32 Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
33 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
34 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934
35 (48 Stat.984).
