

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Continuing Resolution for FY 2024 San Lucy District Budget)**

RESOLUTION NO. 24-326

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only by
6 a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council.

12 **WHEREAS,** by San Lucy District Council Resolution No. SL 09-190-24, the San Lucy District has
13 requested a continuation of the FY 2024 San Lucy District Budget beyond the
14 current fiscal year ending September 30, 2024 and until a FY 2025 San Lucy
15 District Budget is approved; and

16 **WHEREAS,** there are sufficient funds in the San Lucy District account to continue San Lucy
17 District operations; and

18 **WHEREAS,** the Budget and Finance Committee has reviewed the request from San Lucy
19 District and recommends its approval.

20 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council authorizes
21 continued expenditures of the FY 2024 San Lucy District Budget by San Lucy
22 District after September 30, 2024 and until a FY 2025 San Lucy District Budget is
23 approved by Legislative Council resolution.

24 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2024 San Lucy
25 District Budget shall be managed and expended in accordance with Article IX,
26 Section 7 of the Constitution of the Tohono O'odham Nation and the Nation's laws,
27 provided that any amendments or modifications shall be authorized under
28 District Council resolution and submitted for prior approval by the Tohono
29 O'odham Legislative Council.
