16		has authorized and submitted for review and approval a continuing resolution
17		for the FY 2024 Sif-Oidak District Gaming Revenue Budget until October 31, 2024;

19	WHEREAS,	there are sufficient funds in the Sif Oidak District gaming revenue account to
20		continue District operations in accordance with the FY 2024 Sif-Oidak District
21		Gaming Revenue Budget until October 31, 2024; and
22	WHEREAS,	the Budget and Finance Committee has reviewed the continuing resolution for
23		the FY 2024 Sif-Oidak District Gaming Revenue Budget and recommends its
24		approval.
