3		ordinances governing the enrollment and adoption of members and the
4		relinquishment and loss of membership"; and
5	WHEREAS,	in accordance with the Tohono O'odham Nation's Enrollment Ordinance,
6		Ordinance No. 05-81 as amended the Enrollment Committee has received a
7		written statement from 03 tribal members who have expressed their intent to
8		relinquish their membership with the Tohono O'odham Nation and the members
9		are identified in the October 2024 Relinquishment List, which is incorporated by
10	5	this reference; and
11	WHEREAS,	pursuant to Article IX Section 1 of the Enrollment Ordinance,
12		A member of the Nation may relinquish his membership in the
13		Nation by submitting a written statement clearly expressing an
14		intent to relinquish his membership to the Council, a copy of
15		which must be served on the committee. The written statement
16		must he signed by the person wishing to relinquish his membership
17		or, if a minor or incompetent, by the parent(s), guardian or other
18		person legally authorized to act on his behalf. Relinquishment
19		does not require the approval of the Council, but is effective upon
20		receipt of the statement hy the Council and cannot be subsequently
21		denied. Upon recognition by the Council that the individual has
22		renounced his membership, his name shall be deleted from the
23		membership roll.
24	NOW, THER	EFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby
25		recognizes that the three individuals identified in the October 2024
26		Relinquishment List have relinquished their membership in the Tohono
27		O'odham Nation and orders the removal of their name from the Nation's
