

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the FY 2025 Attorney Contract between Sonosky, Chambers, Sachse,**  
**Miller & Monkman, LLP and Tohono O'odham Nation Health Care)**

**RESOLUTION NO. 24-346**

1 **WHEREAS, the Tohono O'odham Legislative Council vests the Legislative Council with the**  
2 **power to "employ legal counsel for the protection and advancement of the rights**  
3 **of the Tohono O'odham Nation" (Constitution of the Tohono O'odham Nation,**  
4 **Article VI, Section 2(a)); and**

5 **WHEREAS, Tohono O'odham Nation Health Care ("TONHC") has prepared and submitted for**  
6 **review and approval the FY 2025 Attorney Contract ("Attorney Contract") between**  
7 **Sonosky, Chambers, Sachse, Miller & Monkman, LLP and TONHC for the amount**  
8 **indicated in attached Exhibit A, incorporated herein by reference; and**

9 **WHEREAS, fees for services for this Attorney Contract will be paid by the FY 2025 TONHC**  
10 **General Budget; and**

11 **WHEREAS, the Health and Human Services Committee has reviewed the Attorney Contract**  
12 **and recommends its approval.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council:**

- 14 **1. Approves the FY 2025 Attorney Contract between Sonosky, Chambers,**  
15 **Sachse, Miller & Monkman, LLP and Tohono O'odham Nation Health Care,**  
16 **which shall be funded from TONHC's General Budget and shall be effective**  
17 **from October 1, 2024, to September 30, 2025.**
- 18 **2. Authorizes the Chief Executive Officer of TONHC to execute the Attorney**  
19 **Contract in substantially the form attached.**
- 20 **3. Authorizes the Chief Executive Officer of TONHC or any designated official**  
21 **to administer the Attorney Contract, provided that any amendments or**  
22 **modifications shall be submitted for prior approval by the Tohono**  
23 **O'odham Nation Legislative Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08<sup>TH</sup>**  
25 **day of OCTOBER 2024 at a meeting at which a quorum was present with a vote of 3,263.3 FOR; -0-**  
26 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
27 **Article VI, Sections 2(a) of the Constitution of the Tohono O'odham Nation, adopted by the**  
28 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
30 **18, 1934 (48 Stat.984).**
