## **LEGISLATIVE ORDER NO. 24-357**

1	WHEREAS,	on July 24, 2024, Patricia Cruz and Eleanor Pablo, who are registered voters of the
2		Tohono O'odham Nation, filed a removal accusation ("Accusation") with the
3		Chairperson of the Judiciary Committee against Pisinemo District Council
4		Representative Eugene Lopez in accordance with the provisions of 12 T.O.C.
5		Chapter 1 - Elections, Article X, Section 11002(C); and
6	WHEREAS,	on September 24, 2024, the Judiciary Committee held a hearing upon the
7		Accusation in accordance with the Constitution of the Tohono O'odham Nation,
8		Elections law, and Reasonable Cause Hearing Procedures and, by Judiciary
9		Committee Resolution Nos. 24-01 and 24-02, found reasonable cause to believe
10		that Representative Lopez committed the offenses of moral turpitude and
11		misconduct reflecting on the dignity and integrity of the Tohono O'odham
12		government; and
13	WHEREAS,	the Judiciary Committee filed its resolutions and the Accusation with the
14	111111111111111111111111111111111111111	Legislative Council secretary on September 25, 2024 in accordance with the
15		provisions of 12 Tohono O'odham Code Chapter 1, Section 11002(C); and
16	WHEREAS,	the Legislative Council has previously adopted the amended "Tohono O'odham
17		Legislative Council Removal Hearing Procedures" pursuant to Legislative Order
18		No. 16-454 to govern removal hearings before the Council; and
19	WHEREAS,	the Elections law requires that the Legislative Council set a bearing on the
20		Accusation.
21	NOW, THER	EFORE, BE IT ORDERED by the Legislative Council that a hearing on the allegations
22		of moral turpitude and misconduct reflecting on the dignity and integrity of the
23		Tohono O'odham government as contained in the Accusation against Pisinemo
24		District Council Representative Eugene Lopez shall be held on October 25, 2024 at
25		10:00 a.m. at the Archie Hendricks Sr. Skilled Nursing Facility Clubhouse
26		building.
27	BE IT FINAL	LLY ORDERED that the removal process before the Legislative Council shall be
28		governed by the "Tohono O'odham Legislative Council Removal Hearing
29		Procedures" previously adopted by the Council pursuant to Legislative Order No.
30		16-454, (1) except that required disclosures shall be provided to the other party
31		and to the Legislative secretary no later than October 18, 2024 and (2) provided
32		that the secretary shall attempt to serve the Accusation on the Accused consistent

with the Procedures and may serve the Accused by posting at his residence or by service to an adult residing at the Accused's residence..

The foregoing Order was passed by the Tohono O'odham Legislative Council on the  $09^{TH}$  day of OCTOBER, 2024 at a meeting at which a quorum was present with a vote of 2,645.85 FOR; 617.45 AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(a) and 1(l); Article XIII of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
