

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Setting October 24, 2024 Special Session to Address FY 2025 Sif-Oidak District Budget)**

LEGISLATIVE ORDER NO. 24-360

1 **WHEREAS, the Legislative Council is vested with the power “to establish rules and**
2 **procedures to regulate all meetings of the Tohono O’odham Council, standing**
3 **committees, boards and special committees.” (Constitution of the Tohono**
4 **O’odham Nation, Article VI, Section 1(a)); and**

5 **WHEREAS, the Legislative Rules of the Tohono O’odham Legislative Council vests the Council**
6 **with the authority to “by majority vote, call for a special session” (Legislative**
7 **Rules of the Tohono O’odham Legislative Council, Article I, Section 1.D.1.); and**


8 **WHEREAS, Article I, Section 2(C) of the Legislative Rules of the Tohono O’odham Legislative**
9 **Council provides that “All Legislative Council sessions shall be held at the Tohono**
10 **O’odham Legislative Council chambers located in Sells, Tohono O’odham Nation,**
11 **with the following exceptions . . . [a] majority of all the legislative representatives**
12 **may vote to hold a session in some location other than the chambers located at**
13 **Sells.”; and**

14 **WHEREAS, the Budget and Finance Committee has requested a special session on October**
15 **24, 2024 to address the FY 2025 Sif-Oidak District Budget.**

16 **NOW, THEREFORE, BE IT ORDERED by the Tohono O’odham Legislative Council that it sets a**
17 **special session on October 24, 2024 at the Archie Hendricks Sr. Skilled Nursing**
18 **Facility Clubhouse to address the FY 2025 Sif-Oidak District Budget, with roll call**
19 **beginning at 11:00 a.m.**

20 **The foregoing Order was passed by the Tohono O’odham Legislative Council on the 10TH day of**
21 **OCTOBER, 2024 at a meeting at which a quorum was present with a vote of 3,263.3 FOR; -0-**
22 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
23 **Article VI, Section 1(a) of the Constitution of the Tohono O’odham Nation, adopted by the**
24 **Tohono O’odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
26 **18, 1934 (48 Stat.984).**


