

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Recognition of Relinquishment from membership in the Tohono O'odham
Nation for the month of November 2024)**

RESOLUTION NO. 24-365

1 **WHEREAS,** Article VI, Section 1(h) of the Constitution of the Tohono O'odham Nation vests the
2 Tohono O'odham Legislative Council with the power to "enact laws and
3 ordinances governing the enrollment and adoption of members and the
4 relinquishment and loss of membership"; and

5 **WHEREAS,** in accordance with the Tohono O'odham Nation's Enrollment Ordinance,
6 Ordinance No. 05-81 as amended the Enrollment Committee has received a
7 written statement from 04 tribal members who have expressed their intent to
8 relinquish their membership with the Tohono O'odham Nation and the members
9 are identified in the November 2024 Relinquishment List, which is incorporated
10 by this reference; and

11 **WHEREAS,** pursuant to Article IX Section 1 of the Enrollment Ordinance,

**A member of the Nation may relinquish his membership in the
Nation by submitting a written statement clearly expressing an
intent to relinquish his membership to the Council, a copy of
which must be served on the committee. The written statement
must be signed by the person wishing to relinquish his membership
or, if a minor or incompetent, by the parent(s), guardian or other
person legally authorized to act on his behalf. Relinquishment
does not require the approval of the Council, but is effective upon
receipt of the statement by the Council and cannot be subsequently
denied. Upon recognition by the Council that the individual has
renounced his membership, his name shall be deleted from the
membership roll.**
