11		O'odham Legislative Council shall determine eligibility for membership or
12		adoption; and
13	WHEREAS,	the Enrollment Program has determined that a number of resolutions approving
14		membership and adoption applications misspelled or incorrectly listed the
15		names of members; and
16	WHEREAS,	the Enrollment Committee recommends that Resolution Nos. 04-172, 07-500, 08-
17		005, 10-401, and 24-260 be amended to reflect the correct names of members
18		identified in the November 2024 Corrected Enrollment Resolution Summary,
19		which is incorporated by this reference.

21		Nos. 04-172, 07-500, 08-005, 10-401, and 24-260 are amended upon the effective
