

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Amendment to the Monthly Age 18 Report for August 2023 to Correct Name)**

**RESOLUTION NO. 24-368**

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Tohono O'odham**  
2 **Legislative Council with the power "to manage any funds within the exclusive**  
3 **control of the Tohono O'odham Nation . . . and to appropriate these funds for the**  
4 **benefit of the nation and its members" provided that "[a]ll expenditures of these**  
5 **funds shall be pursuant to appropriations or budgets" authorized by resolution**  
6 **or ordinance (Constitution, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, on June 28, 1997, the Nation's voters approved Initiative No. IN-01-97, the**  
8 **"O'odham Voice on Use of Gaming Revenues" (the "Initiative"), which authorizes**  
9 **per capita payments to the Nation's members, provided that sufficient gaming**  
10 **revenues are available; and**

11 **WHEREAS, the Ordinance for the Regulation of Gaming Activities Within the Tohono**  
12 **O'odham Nation was subsequently amended to authorize per capita distribution**  
13 **payments in accordance with the Initiative (Legislative Council Resolution No.**  
14 **97-303); and**

15 **WHEREAS, the Trust Agreement with Principal Trust Company requires that a listing of all**  
16 **minor beneficiaries turning 18 that month be presented to the Tohono O'odham**  
17 **Legislative Council to obtain approval to distribute the trust funds to these**  
18 **eligible minor members as they are no longer restricted beneficiaries; and**

19 **WHEREAS, by Resolution Nos. 23-288, the Tohono O'odham Legislative Council approved the**  
20 **Monthly Age 18 Report for August 2023 of eligible minor members who reached**  
21 **the age of 18 and are no longer restricted from receiving their per capita**  
22 **payments; and**

23 **WHEREAS, the Nation's Enrollment Office has identified an incorrect member name on the**  
24 **Monthly Age 18 Report for August 2023; and**

25 **WHEREAS, the Nation's Enrollment Committee recommends that the member's name be**  
26 **corrected in accordance with the Monthly Age 18 Report Amendment Summary**  
27 **November 2024, which is incorporated by this reference; and**

28 **WHEREAS, the Rules Committee has reviewed the Nation's Enrollment Committee's**  
29 **recommendations and recommends approval.**

30 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**  
31 **amending the Monthly Age 18 Report for August 2023, approved by Resolution No.**  
32 **23-288, "Approving the Monthly Age 18 Report for August 2023 of Tohono O'odham**  
33 **Eligible Minor Members and Authorizing Distribution of the Per Capita Payments**




1 and Interest Held in Trust on Their Behalf by Principal Trust Company," to  
2 correct the name of a member in accordance with the attached Monthly Age 18  
3 Report Amendment Summary November 2024.

4 BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council authorizes Principal  
5 Trust Company to commence payment to the non-restricted beneficiary listed on  
6 the Monthly Age 18 Report Amendment Summary November 2024, subject to the  
7 additional requirements of the Trust Agreement and written confirmation of the  
8 beneficiary's current mailing address and other information.

9 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup>  
10 day of NOVEMBER 2024 at a meeting at which a quorum was present with a vote of 3,263.3 FOR;  
11 -0- AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by  
12 Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the  
13 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
14 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
15 18, 1934 (48 Stat.984).






