

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Granting a Right for a Utility Alignment to the Tohono O'odham Utility Authority for
Santa Rosa Village Water Main Extension for Home Site Project No. TU-22-592)**

RESOLUTION NO. 24-376

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage, protect,
2 preserve and regulate the use of property...of the Tohono O'odham Nation" and
3 "to manage... or otherwise deal with lands, or interests in land" belonging to the
4 Nation (Constitution of the Tohono O'odham Nation, Article VI, Section 1(i)(2) and
5 Section 2 (d)); and

6 **WHEREAS,** on May 15, 1991, the Nation adopted the Tohono O'odham Utility Authority's
7 ("TOUA," formerly known as the Papago Tribal Utility, and originally established
8 pursuant to TOLC Resolution No. 08-70) "Second Restated Plan of the Operation
9 for the Tohono O'odham Utility Authority" as adopted by TOLC Resolution No. 91-
10 175 to plan, provide and furnish utility services to all areas within the Nation, to
11 acquire, construct, operate, maintain, promote and expand utility systems to
12 furnish electric, gas, water, sewer and telephone services within the Nation's
13 lands; and

14 **WHEREAS,** the Department of the Interior, Bureau of Indian Affairs, disseminated amended
15 regulations at 25 CFR Part 169 Rights-of-Way over Indian Lands, which provide,
16 in part, that an independent legal entity that is wholly owned and operated by a
17 tribe that owns 100 percent of the trust or restricted interests in land does not
18 need to obtain a BIA right-of-way but instead such tribe shall pass a resolution
19 authorizing access to the entity, without BIA approval, including a legal land
20 description, and shall submit both documents to the BIA for its records (25 CFR
21 §169.004); and

22 **WHEREAS,** on January 18, 2017, the TOLC approved Utility Alignment Recordation
23 Procedures for TOUA, a wholly owned and operated tribal utility through
24 Resolution 17-032; and

25 **WHEREAS,** the Santa Rosa Regional Water System has the technical capacity in both well
26 production and storage capacity to support the proposed expansion to serve the
27 additional home; and

28 **WHEREAS,** under the Provision Public Law 86-121, the Nation submitted a Project Proposal
29 requesting assistance from the Indian Health Services (IHS) for the construction
30 of sanitation facilities to serve new and like-new housing on the Tohono O'odham

1 **WHEREAS, this project proposes to construct the necessary water supply and waste disposal**
2 **facilities; and**

3 **WHEREAS, the new utility alignment is described as a 50 foot wide alignment lying 25 feet on**
4 **each side of the centerline, encompassing 0.63 acres of land more or less, which**
5 **is more particularly described in Attachment A – legal land description, and as**
6 **depicted in Attachment – B survey map; and**

7 **WHEREAS, the Nation's Tribal Historic Preservation Office and Wildlife and Vegetation**
8 **Management Program have provided Cultural Resource and Biological**
9 **clearances for the utility alignment; and**

10 **WHEREAS, the Gu Achi District Council has approved Resolution No. 0624-080, supporting**
11 **the Tohono O'odham Utility Authority and Indian Health Service Project No. TU**
12 **22-592; and**

13 **WHEREAS, TOUA has submitted a complete application to the Nation's Realty Office for the**
14 **approval and recordation of a new utility alignment as required under the**
15 **Nation's Utility Alignment Recordation Procedures; and**

16 **WHEREAS, the Agricultural and Natural Resources Committee has reviewed and**
17 **recommends to the Legislative Council the approval of the utility alignment; and**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby grants**
19 **to TOUA a right to utility alignment for Project TU 22-592 for the Santa Rosa**
20 **Regional Water System extension water main system based on the submittal of an**
21 **acceptable Application for Utility Alignment with all documentation required by**
22 **the Application and which includes an accurate legal land description, in**
23 **accordance with 25 CFR 169.102(b)(1) and a survey grade Map of Definite Location,**
24 **prepared in accordance with 25 CFR §169.102(b)(2) as these sections may be**
25 **amended from time to time, certified by a registered professional engineer or an**
26 **Arizona Registered Land Surveyor.**

27 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby grants approval**
28 **of any encroachment permits for this project, including future individual**
29 **services installed on the system, which may be granted by the Bureau of Indian**
30 **Affairs pursuant to federal regulations to allow the utility alignment or service**
31 **lines to individual customers to cross roads constructed by the Bureau of Indian**
32 **Affairs.**
