

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2025-FY 2028 Baboquivari District Artesia/Little Tucson Community  
Building Project Multi-Year Budget)**

**RESOLUTION NO. 24-379**

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham  
2 Nation,

3 No district council shall expend district funds except pursuant to budgets  
4 authorized under resolutions of the district council and approved by the  
5 Tohono O'odham Council. The management of these funds shall be only by a  
6 treasurer or other authorized officer of the district council who has furnished  
7 a surety bond satisfactory to the treasurer of the Tohono O'odham Nation, and  
8 all expenditures of these funds shall be by checks signed by such treasurer or  
9 other authorized officer and the chairman or vice chairman of the district  
10 council.

12 **WHEREAS,** by Baboquivari District Resolution No. 2024-B-100, the Baboquivari District has  
13 authorized the FY 2025-FY 2028 Baboquivari District Artesia/Little Tucson  
14 Community Building Project Multi-Year Budget, which is incorporated by this  
15 reference, in the amount of \$1,621,402.63; and

16 **WHEREAS,** the Budget and Finance Committee has reviewed FY 2025-FY 2028 Baboquivari  
17 District Artesia/Little Tucson Community Building Project Multi-Year Budget  
18 and recommends its approval.

19 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
20 FY 2025-FY 2028 Baboquivari District Artesia/Little Tucson Community Building  
21 Project Multi-Year Budget effective October 1, 2024 through September 30, 2028  
22 in the amount of \$1,621,402.63 which will be funded by FY 2024 Artesia/Little  
23 Tucson Community Building Project carryover funds.

24 **BE IT FURTHER RESOLVED** by the Tohono O'odham Legislative Council that the FY 2025-FY 2028  
25 Baboquivari District Artesia/Little Tucson Community Building Project Multi-  
26 Year Budget will not change the FY 2025 Baboquivari District Budget amount of  
27 \$4,735,610.33.

28 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2025-FY 2028  
29 Baboquivari District Artesia/Little Tucson Community Building Project Multi-  
30 Year Budget shall be managed and expended in accordance with Article IX,  
31 Section 7 of the Constitution of the Tohono O'odham Nation and the Nation's laws,  
32 provided that any amendments or modifications shall be authorized under




District Council resolution and submitted for prior approval by the Tohono O'odham Legislative Council.




