7	WHEREAS,	the FY 2025 Department of Health and Human Services Division of Senior Services					
8		Title VI Budgets totaling the amount of \$280,912.00 were approved by Resolution					
9		No. 24-145; and					
10	WHEREAS,	the Department of Health and Human Services has prepared and submitted for					
11		review and approval its FY 2025 Title VI Part A, Title VI Part C and Title VI Nutrition					
12		Services Incentive Program (NSIP) Budget Amendments No. 1, which are					
13		incorporated by this reference, and which will adjust operational line items and					
14		increase indirect costs; and					
15	WHEREAS,	the FY 2025 Department of Health and Human Services Title VI Budget					
16		Amendments No. 1 will increase the original budgets from \$280,912.00 to					
17		\$285,680.00, a total combined increase by \$4,768.00; and					
18	WHEREAS,	the Health and Human Services and Budget and Finance Committees have					
19		reviewed the FY 2025 Department of Health and Human Services Division of					
20		Senior Services Title VI Part A, Title VI Part C and Title VI Nutrition Services					
21		Incentive Program Budget Amendments No. 1 and recommend their approval.					
22	NOW, THER	EFORE, BE IT RESOLVED that the Tobono O'odham Legislative Council approves the					
23		FY 2025 Department of Health and Human Services Division of Senior Services					
24		Title VI Part A, Title VI Part C and Title VI Nutrition Services Incentive Program					
25		Budget Amendments No. 1 effective April 1, 2024, as follows:					
26		1. Title VI Part A Elders Program Budget will decrease by \$420.00 from					
27		\$196,530.00 to \$196,110.00.					
28		2. Title VI Part C Caregivers Budget will decrease by \$70.00 from \$75,000.00					
29		to \$74,930.00.					
30		3. Title VI NSIP Budget will increase by \$5,258.00 from \$9,382.00 to					
31		\$14,640.00.

BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham Nation chairperson or any designated official is authorized to administer and expend the FY 2025 Department of Health and Human Services Division of Senior Services Title VI Part A, Title VI Part C and Title VI NSIP Budgets as amended, provided that any amendments or modifications shall be submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14<sup>TH</sup> day of NOVEMBER 2024 at a meeting at which a quorum was present with a vote of 3,263.3 FOR; -0- AGAINST; -0-NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
