The management of these funds shall be only by 6 a treasurer or other authorized officer of the district council who has 7 furnished a snrety bond satisfactory to the treasurer of the Tohono 8 O'odham Nation, and all expenditures of these funds shall be by checks 9 signed by such treasurer or other authorized officer and the chairman or vice chairman of the district council. 10 11 : and 12 by Sells District Council Resolution No. SD-82-24 the Sells District has authorized WHEREAS. 13 the FY 2025 Sells District Sells Community Carryover Supplemental Gaming 14 Budget, which is incorporated by this reference, in the amount of \$309,378.63; 15 and 16 the Budget and Finance Committee has reviewed the FY 2025 Sells District Sells WHEREAS. 17 Community Carryover Supplemental Gaming Budget and recommends its 18 approval. 19 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the 20 FY 2025 Sells District Sells Community Carryover Supplemental Gaming Budget 21 effective October 1, 2024 in the amount of \$309,378.63, which shall be funded by 22 FY 2024 Sells District Sells Community Budget carryover funds. 23 BE IT FINALLY RESOLVED by the Tobono O'odham Legislative Council that the FY 2025 Sells 24 District Sells Community Carryover Supplemental Gaming Budget shall be 25 managed and expended in accordance with Article IX, Section 7 of the 26 Constitution of the Tohono O'odham Nation and the Nation's laws, provided that 27 any amendments or modifications shall be authorized under District Council
