

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Acceptance of the Bureau of Indian Affairs Grant Award and Approving FY 2024 - 2025
PIR 151(1) San Luis Road, Gu Achi District Budget)

RESOLUTION NO. 24-394

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, on April 17, 2023, the Tohono O'odham Legislative Council approved the Amended**
8 **FY 2022-2026 Tribal Transportation Improvement Plan (TTIP), which includes**
9 **PIR 151(1) San Luis Road, Gu Achi District, by Resolution No. 23-134; and**

10 **WHEREAS, the Tohono O'odham Nation ("Nation") was notified of Grant (Contract) No.**
11 **A23AV01100, PIR 151(1) San Luis Road, Gu Achi District, in the amount of**
12 **\$354,505.07 from the U.S. Bureau of Indian Affairs ("BIA"), effective August 30,**
13 **2023 through September 30, 2025; and**

14 **WHEREAS, the Planning and Economic Development Department, Roads Program, has**
15 **prepared and submitted for review and approval its FY 2024 - 2025 PIR 151(1) San**
16 **Luis Road, Gu Achi District Budget, which is incorporated by this reference, in the**
17 **amount of \$354,505.07; and**

18 **WHEREAS, the Agricultural and Natural Resources and Budget and Finance Committees**
19 **have reviewed the FY 2024 PIR 151(1) San Luis Road, Gu Achi District Budget and**
20 **recommend its approval.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
22 **FY 2024 PIR 151(1) San Luis Road, Gu Achi District Budget effective October 1,**
23 **2023, ending September 30, 2025, in amount of \$354,505.07, which shall be funded**
24 **by the Nation's general fund pending reimbursement from the grantor, the**
25 **Bureau of Indian Affairs.**

26 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council hereby authorizes the**
27 **Tohono O'odham Nation chairperson or any designated official to expend and**
28 **administer the budget, as attached, provided that any amendments or**
29 **modifications shall be submitted for prior approval by the Tohono O'odham**
30 **Legislative Council.**
