

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2025-FY 2027 Executive Branch American Rescue Plan Act  
Budget Amendment No. 2)**

**RESOLUTION NO. 24-399**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Tohono O'odham Nation ("Nation") received funding from the United States  
8 American Rescue Plan Act ("Recovery Funds") established by the American  
9 Rescue Plan Act of 2021 ("ARP Act"); and

10 **WHEREAS,** the FY 2022 Executive Branch American Rescue Plan Act Budget in the amount of  
11 \$170,056,409.00 was approved by Resolution No. 22-077 and subsequently  
12 amended by Resolution No. 22-397 in the amount of \$163,072,609.00; and

13 **WHEREAS,** the Executive Branch has prepared and submitted for review and approval its FY  
14 2025-FY 2027 American Rescue Plan Act Budget Amendment No. 2, which is  
15 incorporated by this reference and which will adjust operational line items; and

16 **WHEREAS,** the FY 2025-FY 2027 American Rescue Plan Act Budget Amendment No. 2 will  
17 decrease by \$5,918,804.90 from \$163,072,609.00 to \$157,153,804.10, which  
18 transfers \$3,148,897.00 to the Sif Oidak District ARPA budget and \$2,769,907.90 to  
19 fund the Membership Economic Impact Payment; and

20 **WHEREAS,** the Budget and Finance Committee have reviewed the FY 2025-FY 2027 Executive  
21 Branch American Rescue Plan Act Budget Amendment No. 2 and recommend its  
22 approval.

23 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
24 FY 2025-FY 2027 Executive Branch American Rescue Plan Act Budget Amendment  
25 No. 2 effective March 11, 2021 ending December 31, 2026, which includes a  
26 \$5,918,804.90 decrease from \$163,072,609.00 to \$157,153,804.10 that shall be  
27 funded by the American Rescue Plan Recovery Fund.

28 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
29 Nation chairperson or any designated official is authorized to administer and  
30 expend the FY 2025-FY 2027 Executive Branch American Rescue Plan Act Budget  
31 as amended, provided that any amendments or modifications shall be submitted  
32 for prior approval by the Tohono O'odham Legislative Council.


