7		tradition, by providing general welfare assistance, including Indian general
8		welfare benefits within the meaning of Internal Revenue Code Section 139E; and
9	WHEREAS,	the Nation recognizes that as a direct result of the COVID Pandemic the current
20		economic conditions have placed additional financial burdens on the Tohono

BE IT FURTHER RESOLVED that the FY 2025 Tohono O'odham Nation Membership Economic Impact Payment II budget and its funds are not subject to probate or beneficiary payments.

BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham Nation chairperson or any designated official is authorized to administer and expend the FY 2025 Tohono O'odham Nation Membership Economic Impact Payment II Budget, provided that any amendments or modifications shall be submitted for prior approval by the Tohono O'odham Legislative Council.
