14	:	name changes of enrolled members as a result of marriage, divorce, legal
15		adoption, or for other reasons; and
16	WHEREAS,	the Enrollment Committee recommends that Resolution Nos. 184-83, 93-402, 07-
17		706, 09-167, 10-439 and 14-438 be amended to reflect the legal name changes of
18		members identified in the December 2024 Legal Enrollment Resolution
19		Summary, which is incorporated by this reference.
